Treasurer's Report: Kari Walton

Reporting lost check from 21-22 school year. Kari Walton contacted the IRS to receive the correct 1099 forms. Year End Audit edits were made and the report submitted.

Membership Report: Andy Walsh

At the time of the meeting, a total of 48 out of 424 staff are potential members. We have 370 SLPTU members. 6 tier 1 teachers.

Community Action for Public Education (CAPE): Samantha Waibel

On Monday, February 6th members of the Executive Committee met with Education Minnesota to learn the details of the Organizing for Settlement (OFS) Grant as a part of the application process. We have budgeted for roughly \$35,000. As the first order of business, a SLPTU t-shirt has been designed and will be ordered (\$12,000), members should look for a survey to claim their shirt.

President's Report: Scott Smith

A reminder was given to union leaders to conduct union business and communications with members outside of their teaching hours.

Following the required cyber security training, remember to be on alert for spam/phishing emails which are being sent as a test.

Communication Initiative Update - Kelsey Cassidy is leading this initiative moving forward. Any members not receiving emails should contact Kelsey. SLPTU will be utilizing Hustle to text members by the end of March. The final step of implementation of the Communications Initiative will be an SLPTU website, coming soon.

The Negotiations Committee met to determine a time frame for initial surveys. Current planning estimates that negotiations with district leaders will begin in May 2023. A lead negotiator for SLPTU has not been determined by the committee.

Education Minnesota:

Scott Smith shared on Erin Azer's behalf that more information is to come about an EdMN Pension Presentation on March 6th.

Building Reports

EC/ABE - Center based staffing issues continue. ECSE teachers are asking/nervous about the proposal at the legislative level to combine ECSE with DHS.

CV - interested in the subbing survey results

NP - wondering if changes to building goals sustain the opportunity for staff to earn QCOMP?

PT - behavior concerns, short staffed

WCSI - concerns about potentially regularly missing prep

WW 5-6 - behavior concerns, members are being denied access to furthering education

WW 7-8 - sub concerns (covering 70-80 students at a time), new para hired for Structured Day Pilot program vs hiring for IEP needs

HS - behavior concerns, concerns about vagueness in contract related to "District 16 policy"

SLPTU BUSINESS:

Questions About Absences from Human Resources

The Executive Committee is aware that some staff are being questioned about their absences across the district.

2021-2023 Teacher Master Agreement:

- 1. Teachers who have been absent from work for five (5) or more consecutive working days must furnish a physician's certificate indicating that such absence was due to illness and the teacher has returned to good health and is able to return to work in order to qualify for leave pay and in order to return to work.
- 2. The District may also require a physician's certificate for absence of shorter duration.

The executive committee is aware of this HR decision and communicated some concerns to HR regarding this practice. The Executive Committee fully supports SLPTU members using their earned benefits to their full extent.

RA Nomination and Selection
