Treasurer's Report: Kari Walton

Membership Report: Andy Walsh

At the time of the meeting, a total of 50 out of 424 staff are potential members. We have 368 SLPTU members. 6 tier 1 teachers.

Community Action for Public Education (CAPE): Samantha Waibel

More information is needed to submit the final application for the grant. Next steps involve executive council members meeting with EdMN to understand the terms of the agreement.

President's Report: Scott Smith

Members Rights Advocate (MRA) Training on February 11th is open to executive committee members, training one advocate per building is recommended.

Three names were submitted for attending the Minnesota Representative Convention (MRC). Scott Smith, Mary Mohr-Scinocca and Jan Burda will attend.

Education Minnesota:

Erin Azer, EdMN field representative, shared that Fridley and Columbia Heights will be at the MRA training. She encourages looking for opportunities to partner with them such as scheduling an in person or virtual pension meeting with an EdMN expert. A bargaining conference in January was attended by two SLPTU members. MEA Online will be back up and running at the end of January.

Pensions - link to come, what EdMN is doing Communications grant - no money

Building Reports

EC/ABE - Still short paraprofessionals though the overall sub situation is better

CV - Substitute issue is continuing, members are eager to share topics to negotiate, continued slow responses from Human Resources

NP - Wondering about Learner Map/Profile expectations at each school, questions about conference prep time being only a half day

PT - Concerned about lack of support for student behaviors

WCSI - No new issues, more frequent substitute teachers, substitute teachers report that the pay increase has helped

WW 5-6 - Substitute shortage seems to be better at WW 5-6, not as many teachers are being asked to sub. Concerned subs are being shuffled out of the positions they signed up for still WW 7-8 - Staff are being asked to complete additional responsibilities with no shifting of current responsibilities or additional compensation

HS - Student behavior concerns with a lack of consequences continue to be an issue, staff are feeling unheard

Next School Year Staff Assignments

Staff are asked to notify Human Resources of their decision to leave by April 1st before being held to continuing contract. If something changes after April 1st, the local union can support staff members in discussions with Human Resources. Staff assignments for the following school year are shared by June 1st.
