At the time of the meeting, a total of 49 out of 425 staff are potential members. We have 370 SLPTU members. 6 tier 1 teachers. In unique scenarios, clarification has been provided to individuals about the difference between tier 1 and tier 2 licensure. As members begin wearing their SLPTU merchandise, all new members will also be given a free t-shirt.

Community Action for Public Education (CAPE): Samantha Waibel

Considering ways to use the Organizing for Settlement (OFS) grant in the remaining months of the school year (treats at each building, end of year social).

President's Report: Scott Smith

Support is available to members as soon as they join the union. This winter, our member rights advocates were able to support a new member in meetings with administration within one week of signing up.

Members considering leaving Spring Lake Park should follow the contract language to the best of their ability. If the contract is settled by the end of the year, the language is the contract holds. If the contract is not settled by the end of the year, members have until July 15th to contract human resources about their intent to leave.

A small, random sample of teachers were asked to reflect via survey on the opportunity to have a Flexible Working Day on March 10th. This data will be shared with human resources and district administration.
